## Fine Arts & Fine Crafts Show—7th Annual

### Media:

Lathrup Village Art In The Park is juried and open to all artists. The jury fee is \$20 per medium. All exhibited work must be original in concept and must have been created by the accepted applicant. No work made with commercial kits, molds, plans or stencils, or prefabricated forms are allowed. Antiques, plants, or imports are not allowed. Work displayed at this fair must be in the category in which the artist was selected and accepted. An artist cannot, for example, gain acceptance with decorative pottery and offer display boards of ceramic jewelry. Any artist whose work is found to be unoriginal or inconsistent with their submitted photos will be asked to leave the fair. LV Art In the Park reserves the right to refuse exhibition of work that is not consistent with the artist's application for acceptance and submitted photos. Qualifiers will circulate at random during the show to ensure that all work shown is in compliance with these guidelines. *Note regarding jewelry*—Artists wishing to sell jewelry in any form/manner must apply in the jewelry category.

### Jury Process:

Submit five images (CD or photographs), four that are representative of your work, and which also *clearly depict the artist in the process*, and one that clearly shows your booth. Artwork will be evaluated on the criteria of skill, originality, impact, and design. Artwork shown in your booth shot should be representative of your current work. Label CD/photo with name, medium, and price range. Provide an Artist Statement and techniques you use in developing your product.

## Application Process:

1. Complete application form.
2. Two checks made payable to: Lathrup Village Community Foundation; \$155 booth fee and \$20 non-refundable jury fee.
3. Submit five images (CD or photographs), four that are representative of your work, and which also *clearly depict the artist in the process*, and one that clearly shows your booth. Artwork will be evaluated on the criteria of skill, originality, impact, and design. Artwork shown in your booth shot should be representative of your current work. Label CD/photo with name, medium, and price range.
4. Enclose an appropriately sized, legible self-addressed, postage paid envelope to return your CD or photographs and acceptance notification.
5. Enclose an Artist Statement.
6. Enclose a statement outlining the techniques and processes you use in developing your product.
7. Above materials must be postmarked no later than May 14, 2010.

## Fees:

Jury Fee: \$20 non-refundable

Booth Fee: \$155 postmarked on or before May 14, 2010

Booth Fee: \$170 received after May 14, 2010

## Rules:

Artists are responsible for their own property and for furnishing their own tents and chairs. Booth space will be 10' x 10'; ample aisle space. Artists are responsible for insurance and protection of artwork and display. Sponsor will not be responsible for damage and/or loss to work or display. Electricity will not be provided. **DO NOT BREAK DOWN EARLY.** Absolutely no refunds. Must provide the names of ALL individuals that will be in your tent. Set up Friday, June 25, from 6 p.m. – 8 p.m. and Saturday, June 26, from 6:30 a.m. – 9:30 a.m. Artists will not be allowed to enter for set up after 9:30 a.m. on Saturday, June 26. Tear down Sunday, June 27, 5:00 p.m.
